## EVER HIGHER HUMAN PRICES GUARANTEED

It is shameful, but no surprise, to learn that specifics that contracts between for-profit prison companies and state, local, and federal governments often provide for. Two common techniques either guarantee prison occupancy rates (thus creating prisoner lockup quotas) or, force us taxpayers to pay for unused space if the prison population decreases (essentially creating a tax for lower prison population rates). Some of these contracts require 90 to 100% prison occupancy. Contract clauses like these obviously push criminalization of arrestees and of those with demographic characteristics which make them vulnerable to arrest. People should never be profit incentives.

More specifics about contracts with for-profit prison companies include: 1) That 65% of for-profit prison contracts included these occupancy guarantees in the form of quotas or required payments for empty prison cells. Such arrangements result in guaranteeing profits for for-profit prison corporations.

### NEARLY 30 MILLION ENSLAVED WORLDWIDE

People are enslaved as forced laborers and sex workers, as child soldiers and child brides in forced marriages, debt bondage, and human trafficking. Mauritania and Haiti have the highest proportion of slaves compared to population size, while India and China have the highest overall numbers. The other highest prevalence countries are: Pakistan, Nepal, Moldova, Benin, Cote d'Ivoire, The Gambia. Ten countries in Asia and Africa account for 76% of the enslaved population, but there were enslaved people found in every single one of the 162 countries investigated. There are 60,000 enslaved people living in the U.S. today.

This information appears in the first Global Slavery Index, compiled by the Walk Free Foundation (80 Birdwood Parade, Dalkeith, Western Australia, \$1.10 U.S. postage, 1st ounce.)

Occupancy guarantee clauses in these contracts range from 80% to 100%. The most frequent occupancy guarantee requirement is 90%. In Arizona (where three for-profit prisons have a 100% occupancy requirement), Louisiana, Oklahoma, and Virginia have contracts with the highest occupancy guarantee requirements of between 95% and 100%. An occupancy requirement for three for profit prisons in Colorado has added \$2 million to their cost. A 20 year deal in Ohio includes a 90% quota.

Similarly, Obama's 2015 budget has a continuation of an immigrant detention imprisonment quota passed by the House of Representatives in 2006. Under it, ICE is required to hold at least 34,000 immigrants each day in for-profit detention centers, which costs \$160 a day, or \$2 billion a year. This quota is the main reason so many immigrants who haven't committed any crimes are arrested and detained by ICE.

## Life Sentences Increase

As of 2012, there are now nearly 160,000 prisoners with life sentences in U.S. prisons. Almost 50,000 people have life sentences without parole (LWOP). The lifer population has more than quadrupled in size since 1984. One in nine people in prison currently have life sentences and nearly a third of lifers will never have a chance at a parole hearing; they are certain to die in prison.

LWOP sentenced prisoners have increased 22.2% since 2008, to 49,081. Approximately 10,000 lifers have been convicted of nonviolent acts. Nearly half of lifers are African American and 1 in 6 are Latino. More than 10,000 life-sentenced prisoners have been convicted of crimes that occurred before they were 18 and nearly 1 in 4 have LWOP

## PRISON HUNGER STRIKE SUSPENDED

### What has been won:

A prison hunger striker leadership collective meeting to decide on the suspension, including phone contact with those transferred from Pelican Bay to New Folsom for medical reasons.

A meeting with organized prisoners at San Quentin, Tehachapi and Calipatria with their wardens agreeing to meet prison specific demands.

Beginning the hunger strike with 30,000; 100 went 59 days. Others joined with work stoppages.

Prison system reduction of violence.

Prisoner discipline with no violence despite guard provocation.

Outpouring of outside support locally and nationally, and widespread coverage.

Unity of family members and other community supporters across differences.

Public hearings scheduled in October in California by supportive legislators.

### The Struggle Continues

Herman Wallace of the Angola 3.

September 25, 1941 - October 4, 2013

"He was the best of us. As long as we remember him, he lives on.

Separated but never apart, never touching, but always connected."

--Albert Woodfox of the Angola 3.

Wallace's lawyers at his request, will continue to press his lawsuit challenging his unconstitutional confinement in solitary for over 40 years. His hope was that this will help others, such as Albert Woodfox, not to be forced to continue to suffer such cruelty.

"Nothing can justify the cruelty that the state has inflicted on Woodfox" stated Amnesty International, which is launching a campaign for his release. Woodfox is the one remaining member of the Angola 3 still imprisoned and is being held in the Wade Correctional Center in Homer LA. Robert H. King, the third of the Angola 3, was released after 29 years in solitary.

The United Nations Special Rapporteur on torture, Juan E. Méndez, called for Woodfox's immediate release from solitary. "Keeping Albert Woodfox in solitary confinement for more than four decades clearly amounts to torture and it should be lifted immediately. I am deeply concerned about his physical and mental condition."
