### HIGHLIGHTS FROM THE JULY 1, 2020 MASSACHUSETTS DEPARTMENT OF CORRECTION'S INSTITUTIONAL FACT CARDS<sup>1</sup>

- 1. The total number of prisoners under Massachusetts (MA) jurisdiction<sup>2</sup> on July 1, 2020 was 7,312, a decrease of 1,525 prisoners (17%) since July 1, 2019. (Table 8, page 11)
- 2. Of the 7,312 prisoners under MA jurisdiction, the total actually incarcerated in MA facilities was 7,040. 272 MA prisoners were outside the Commonwealth, a decrease of 115 prisoners (30%) from July 1, 2019. (Table 8, page 11)
- 3. The total number of prisoners housed in MA on July 1, 2020 (7,040) was 1,410 below the number housed on July 1, 2019 or a decrease of 17%. (Table 8, page 11)
- 4. The total number of criminally sentenced prisoners housed in MA on July 1, 2020 was 6,568, a decrease of 1,080 (14%) from July 1, 2019. The number of criminally sentenced prisoners held in MA facilities was 93% of the total housed in MA. Civil Commitments accounted for 5%, Pre-Trial prisoners 0.9%, and prisoners under observation 0.7% of the remaining 472 prisoners confined in MA prisons. (Table 1, page 4)
- 5. Of the 7,040 prisoners housed in MA prisons on July 1, 2020, 1,075 (15%) were in Maximum Security a decrease of 336 (24%) from July 1, 2019; 5,267 (75%) were in Medium Security a decrease of 695 (12%); 606 (9%) were in Minimum Security a decrease of 1,277 (68%); and 92 (1%) were in Pre-Release a decrease of 102 (53%). (Table 1, page 4; Table 8, page 11)
- 6. The racial breakdown of the prisoners housed in MA prisons on July 1, 2020 was: Caucasian 2,910 (41%), African-American 2,034 (29%), Hispanic 1,853 (26%), Asian 111 (2%), Native American 42 (1%), and Other 90 (1%) (Table 2, page 5)
- 7. From July 1, 2019 to July 1, 2020, the number Caucasians decreased by 712 (20%); African-Americans by 306 (13%); Hispanics by 317 (15%); Asians by 2 (2%); Native Americans by 8 (16%); and Other by 12 (11%). (Table 8, page 11)
- 8. Governing Offenses for prisoners criminally sentenced and housed in MA on July 1, 2020 broke down as: Person Offenses 3,790 (54%), Sex Offenses 1,185 (17%), Drug Offenses 740 (11%), Property Offenses 344 (5%) and Other Offenses 509 (7%). (Table 4, page 7)
- 9. Of the criminally sentenced prisoners housed in MA on July 1, 2020, 740 (11%) had a drug conviction as their governing offense. The institution with the highest percentage was BPRC (64%); the institution; SMCC was the second highest (57%). Bridgewater was the lowest (0%). Others were: NCCI 4%, SBCC 5%, MCI-N 6%, and OCCC 7%. (Table 4, page 7)
- 10. Of the criminally sentenced prisoners housed in MA on July 1, 2020, 1,185 (17%) had a sex conviction as their governing offense. MTC had the highest percentage was MTC 85%; the second highest was NCCI (54%). Minimum and Pre-Release facilities had no prisoners serving a Sex Governing Offense. (Table 4, page 7)
- 11. Of the criminally sentenced prisoners housed in MA on July 1, 2020, 3,790 (54%) had a person conviction as their governing offense. MCI-F had the highest percentage (75%); the second highest was MCI-N (75%). MTC had the lowest (11%). (Table 4, page 7)

- 12. The number of prisoners housed in MA with a Governing Offense of a Person Offense decreased by 464 (11%) from July 1, 2019; with a Sex Offense decreased by 78 (6%); with a Drug Offense decreased by 253 (25%); with a Property Offense decreased by 160 (32%); and with an Other Offense decreased by 125 (20%). (Table 8, page 13)
- 13. The total number of prisoners housed in MA serving over fifteen years and up and including life without parole (First Degree) on July 1,2020 was 3,064 a decrease of 53 or 2% from July 1, 2019: 15+ 1,141 (16%), Second Degree Life 903 (13%), and First Degree Life 1,020 (15%). (Table 3, page 8; Table 8, page 13))
- 14. The number of criminally sentenced prisoners housed in Ma serving Second Degree Life sentences on July 1, 2020 was 903 (14%) and 1,020 (16%) were serving First Degree, i.e., Life Without Parole for a total of 1,923 (29%) lifers a decrease of 72 from July 1, 2019. (Table 3, page 8; Table 8, page 13)
- 15. The number of First Degree Lifers on July 1, 2020 was 26 lifers below those serving First Degree Life on July 1, 2019 a decrease of 0.2%. The number of Second Degree Lifers on July 1, 2020 was 46 lifers below those serving Second Degree Life on July 1, 2019 a decrease of 5%. (Table 5, page 10; Table 8, page 13)
- 16. On July 1, 2020, lifers incarcerated at MCI-Norfolk numbered 691 or 55% of the total MCI-Norfolk population and 36% of the total number of lifers housed in MA. MCI-Shirley had the next highest number of lifers 274 or 24% of that institution's total number of prisoners, followed by OCCC with 249 or 34% of that institution's total. (Table 3, page 8; Table 5, page 10)
- 17. Maximum Security institutions on July 1, 2020 operated at 55% of capacity; Medium Security institutions at 78%; Minimum/Pre-Release institutions at 48%. (Table 7, page 12)
- 18. Of the 272 MA prisoners not held in the Commonwealth on July 1, 2020, 62 were serving life sentences. The difference between the total number of lifers under MA jurisdiction (1,985) and the total number of lifers housed in MA prisons. (Calculation made by the Lifer's Group Inc.)
- 19. The Operational Capacities of MA prisons on July 1, 2020 totaled 10,180. The number of prisoners actually held in MA on that date was 7,040 31% below total Operational Capacity. (Table 6, page 11)
- 20. The oldest prisoner in MA prisons on July 1, 2020 was age 91 and housed in MCI-Shirley. In four other facilities, the oldest prisoner was 80 years or older (1 at age 80, 1 at age 81, 1 at age 83, and 1 at age 87). (Table 2, page 7)
- 21. On July 1, 2020, the frequency distribution of the average ages of prisoners housed in MA prisons was: 34 39 (3), 40 49 (11), and 50 (1). On July 1, 2019, the distribution was: 34 39 (3), 40 49 (10), and 50 (1). (Table 2, page 7 and the Lifer's Group Inc. report on the DOC Institutional Fact Cards for July 1, 2019)
- 22. The average age of prisoners held under Massachusetts jurisdiction on July 1, 2020 was 43. (Table 2, page 7)

#### Commentary Notes

- 1) The precipitous decrease in Pre-Trial numbers [190 on July 1, 2019 (Lifer's Group Inc. report on Institutional Fact Cards as of July 1, 2019) to 29 on July 1, 2020 (Table 1, page 4)] reflects the transfer of Pre-Trial detainees to the Suffolk County jail and not releases to the street.
- 2) It is notable that two years after the Commonwealth passed the 2018 Criminal Justice Reinvestment statute, the DOC spent more money on prisons last year even though the number of people incarcerated dropped. The ballooning DOC budget is due in no small part to the growing cost of health care necessitated by the Executive Branch's unwillingness to use the tools at its disposal medical parole and commutations to lower the growing elderly prisoner population. According to a Lifer's Group Inc. report on the expenditures and staffing levels of the DOC for Fiscal 2020, spending increased by \$40 million (6%), while the number of prisoners decreased by 7% and the number of Full Time Employees decreased by 6%.
- 3) The state's minimum security and pre-release facilities continue to operate well below their operational capacities. (See Table 7, page 10.) The DOC's failure to use fully (and expand) minimum and pre-release facilities means that far too many people are forced to complete their sentences in higher security that lacks the breadth of resources and opportunities that allow prisoners to successfully transition back into the free world.
- 4) Massachusetts continues to incarcerate minorities well above their proportion of the population. According to the 2010 US Census, Massachusetts' population was comprised of 10.5% Hispanic, 8.1% African/American, 6.0% Asian, 0.1% Native American; while the DOC racial breakdown on July 1, 2020 was 29% African/American (21% higher than the representative free world number), 26% Hispanic (15.5% higher), and 1% Native American (.9% higher). (See Table 8, page 11.)
- 5) While there has been a lot of talk of reforming prisons by changing drug laws, it is important to note that only 11% of Massachusetts prisoners have a drug-related governing offense. (See Table 4, page 7.)
- 6) MCI-Norfolk continues to be the only prison where the majority of the population is serving a life sentence (55%). while 36% of the DOC lifer population is housed at MCI-Norfolk, the Department fails to provide the differentiated programming and assistance this population requires. Instead, the DOC continues to force lifers to compete with non-lifers for access to rehabilitative programming and educational opportunities where access is determined by length of time to parole. (See Table 5, page 8.)
- 7) This year's report shows a continued decrease in the prisoner population. There has been, however, a quiet push by Governor Baker to build prisons. The governor has access to over \$500 million in bonds that can be used to build or to remodel prisons. This was first publicly reported by Lois Ahrens, Founding Director of The Real Cost of Prisons Project (5 Warfield Place, Northampton, MA 01060), who successfully lobbied to stop Governor Baker from using \$50 million to build a new prison to house women.
