AUTHOR'S COMMENT: It is notable that over 15 years, 76 LWOP prisoners, comprising 7.4% of the LWOP prisoners incarcerated during that time (1), reversed their verdicts because the courts found they were wrongfully convicted, after an average of 29 years of wrongful imprisonment (2). But this represents only those who, with extraordinary efforts, were able to prove their innocence. It is virtually certain that many others, although also wrongfully convicted, are not able to achieve such an elusive result. Such high percentages of wrongful convictions represent unacceptable error rates, arguing forcefully that all LWOP prisoners should be offered a second chance by becoming eligible for possible parole release.
