

DEAR MADAM OR SIR:

MY NAME IS: 'JACKIE EMMITT MOOREHEAD', I AM A SIXTY-EIGHT YEAR OLD MALE, I HAVE BEEN IMPRISONED IN THE NORTH CAROLINA PRISON SYSTEM FOR THE PAST THIRTY-THREE YEARS, AND/OR SINCE THE 26th, DAY OF SEPTEMBER 1986.

I AM PRESENTLY HOUSED AT THE: "ODOM CORRECTIONAL INSTITUTION," OBSERVATION MINIMUM CUSTODY FACILITY, IN JACKSON, NORTH CAROLINA.

THIS SO CALLED OBSERVATION MINIMUM CUSTODY FACILITY, IS OPERATED VERY SIMILAR TO A: "NORTH CAROLINA DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ADULT CORRECTION-PRISONS," (NCDPS- CLOSED CUSTODY FACILITY, THE ONLY EXCEPTIONS ARE, THE ODOM CORRECTIONAL FACILITY, IS NOT UNDER ARMED GUARD SUPERVISION, AND THE INMATES ARE TRANSPORTED IN HAND CUFFS ONLY, EXCEPT FOR SEGREGATION (LOCKUP), INMATES ARE TRANSPORTED IN FULL RESTRAINTS. BESIDES THE FOREGOING THE ODOM CORRECTIONAL INSTITUTION, IS SURROUNDED BY TWENTY FEET HIGH, DOUBLE GRAHWIRE TOPPED, SECURITY FENCES, AND IS STRICTLY CONTROLLED MOVEMENT, WITHIN THE COMPOUND.

THERE ARE AT LEAST FOUR SEPARATE OBSERVATION MINIMUM CUSTODY (HONOR GRADE), FACILITIES IN NORTH CAROLINA, THAT WERE CREATED TO PRESUMEDLY, SCAM NEED FUNDS OUT OF THE UNITED STATES GOVERNMENT, THESE ABOVE FACILITIES WERE CREATED WITHIN THE PAST SEVEN YEARS.

I HAVE BEEN HOUSED IN THE ODOM CORRECTIONAL INSTITUTION, FACILITY SINCE JUNE 12th, 2018.

ALSO THE NCDPS-P IMPLEMENTED THE DEROGATIVE AND OFFENSIVE TERM "OFFENDER," WHENSOEVER REFERRING TO ITS PRISONER, INMATES, OR CONVICTS. WHICH SUITS THE NCDPS-P'S, IDEOLOGY BELIEFS, "THAT ONCE AN "OFFENDER," ALWAYS AN OFFENDER!" AS NORTH CAROLINA, HAS THE LARGEST PRISON POPULATION PER CAPITA, IN THE UNITED STATES OF AMERICA.

LASTLY THE NCDPS-P ALLOWS ITS INDIVIDUAL FACILITIES (OF ABOUT EIGHTY FACILITIES), TO IMPLEMENT THEIR OWN SEPARATE WHIMSICAL POLICY AND PROCEDURES, THAT GENERALLY NULLIFIES THE NCDPS-P'S AGENCY POLICY AND PROCEDURES. SUCH AS, THE NCDPS-P'S AGENCY POLICY AND PROCEDURES, STIPULATES INMATES ARE GENERALLY ALLOWED THREE TRANSFER BAGS (THIRTY-THREE-HUNDRED CUBIC INCHES), OF ANY KIND OF PERSONAL PROPERTY, WHICH INCLUDES BOOKS, (BUT DOES NOT INCLUDED LEGAL MATERIALS, AND BOOKS, WHICH IS UNDER A DIFFERENT POLICY).

I HAVE A: "TITLE 42 UNITED STATES CODE, SECTION 1983." CIVIL COMPLAINT NO. 5:16-CT-3343-F, ON FILE IN THE UNITED STATES DISTRICT COURT, FOR THE EASTERN DISTRICT OF NORTH CAROLINA, PO BOX 25670, RALEIGH, NORTH CAROLINA 27611. CONCERNING THE INDIVIDUAL NCDPS-P FACILITIES, IMPLEMENTING POLICY AND PROCEDURE, LIMITING INMATES TO THE POSSESSION OF FIVE BOOKS. THE

PAROLE SINCE SEPTEMBER 2006, AND HAVE BEEN DENIED PAROLE THIRTEEN TIMES.

FIVE BOOK LIMITATION INCLUDES RELIGIOUS; EDUCATIONAL;  
AND THEIR RESEARCH BOOKS, SUCH AS: BIBLICAL CONCORDANCE;  
BIBLICAL DICTIONARY; BIBLICAL LANGUAGE DICTIONARY, HAFTARAH;  
PRAYER BOOK, AND SO FORTH. JUST TO NAME A FEW OF NECESSARY  
AND ESSENTIAL BOOKS NEEDED BY INMATES TO FURTHER THEIR  
EDUCATION, AND/OR RELIGIOUS COMPREHENSION, AND HOPEFULLY  
STOP THEIR RECIDIVISM OF CRIMINAL BEHAVIOR.

I ALSO FILED A: TITLE 42 UNITED STATES CODE, SECTION 1983,  
IN THE HEREIN COURT, CONCERNING NCDPS-P USING COERCION  
TO EMPUL ELDERLY INMATES, AS MY SIXTY-EIGHT YEAR OLD SELF,  
TO ACCEPT JOB, WORK ASSIGNMENTS, THAT WERE NOT ORDER  
BY MY SENTENCING JUDGE, ON 23RD DAY OF SEPTEMBER 1986,  
WHEN HE PRONOUNCED MY MINIMUM, AND MAXIMUM EIGHTY  
YEAR LIFE SENTENCE, WHICH IS VERY SIMILAR TO "BEATING A  
DEAD HORSE OR BEAST OF BURDEN." AND A VIOLATION OF MY  
EIGHTH AMENDMENT RIGHT, TO BE FREE OF CRUEL AND
